TLB CAMP POLICIES

BELONGINGS

- * All summer campers should WEAR their bathing suit under their play clothes every day. Even if they tell you they don't want to go in the water. They might not want to go in the sprinklers but we might play water games, play at the water table or your child might change their mind. If it is raining, it might clear up by the time we go outside so please put on those suits! It will significantly delay our schedule when our campers have to change at camp.
- * Apply sunblock AND bug spray before camp. We spend a lot of time outdoors.
- * Label all belongings with your camper's name.
- * No stuffed animals or toys from home.
- * Your camper must wear closed toe, rubber soled shoes to camp. **No flip flops or sandals.**
- * Your camper needs water shoes to play in the sprinkler park. It is a Lincoln Park policy.

FOOD

- * Pack your camper's lunch and snacks in a lunch box. Make sure to label EVERYTHING.
- * Do not pack your snack or lunch in a plastic bag.
- * Do not use glass containers or bottles.
- * For the safety of our campers, **we do not allow nuts or foods containing nuts or nut ingredients.**

BACKPACK CHECKLIST

DAILY BACKPACK CHECKLIST for 2.5-3 years old

- * LABELED Towel - This is the item most campers lose.
- * Plastic bag with underwear and clothes to change into after water games. Swimsuits will go into the bags.
- * Labeled plastic bag with daily diapers/underwear/wipes
- * Labeled lunchbox with snack, lunch and water all labeled.
- * If your child stays for aftercare or drinks a lot of water, pack two labeled water containers
- * Water shoes
- * If it is a rainy day, please send your camper with a waterproof jacket. Make sure to label it as campers often take them off and leave them behind when the sun comes out.

STAYS AT CAMP

- * Small sleeping bag or sheet/blanket for naps for full day campers.
- * One backup outfit, 2 diapers or underwear in labeled ziplock bag

DAILY BACKPACK CHECKLIST for 4 years and up

- * LABELED Towel - This is the item most campers lose.
- * Plastic bag with underwear and clothes to change into after water games. Swimsuits will go into the bags.
- * Labeled plastic bag with extra underwear if necessary.
- * Labeled lunchbox with snack, lunch and water all labeled
- * If your child stays for aftercare or drinks a lot of water, pack two labeled water containers
- * Water shoes
- * If it is a rainy day, please send your camper with a waterproof jacket. Make sure to label it as the campers often take them off and leave them behind when the sun comes out

STAYS AT CAMP

- * One backup outfit in labeled ziplock bag

ARRIVAL

- * Camp schedule is 9am-4pm. Early care and after care are available for an additional fee under the products section on our website.
- * If you are going to be absent or late, please email camp at chirp@threelittlebirds.com or call prior to the start of the session at 201-984-0555 and leave a message.
- * We will open our doors at 9am. If you arrive a few minutes early, please wait at the bottom of the steps.
- * 2.5-4 year campers will be dropped off and say good-bye to their caregivers in our lobby.
- * K-7th graders will be dropped off at the side gate.
- * If you arrive late, please go to the front doors and ring the buzzer. If your camper's group is outdoors, you will need to drop off their belongings at camp, sign them in and then drop them off at the park with their counselor.
- * Parents/caregivers must sign the daily attendance log at the beginning and end of the camp day.
- * We do not have parking inside for strollers, bicycles or scooters. They may be locked outside, however, tlb is not responsible for lost or stolen items.

DISMISSAL

- * 4pm dismissal will be outside. 2s, 3s and 4s will dismiss at the bottom of the front stairs. You can wait for your camper at the bottom of the stairs. K-7th grade will dismiss at the side gate. If it is raining, pick up will be in the lobby for all groups.
- * If you are late for pick-up, you will be charged a late fee of \$15 per 15 minutes. Please message your counselor via Brightwheel if you are running late.

AFTER CARE

- * If your camper stays for after care, you can pick them up in the lobby. On nice days we will be outside until 5pm. You can come to the lobby, grab your child's belongings and pick them up at the park.
- * If something comes up and you need after care for your child, please let their Head Counselor know via Brightwheel.

COMMUNICATION

* At the start of camp, you will be invited to Brightwheel, a communication app. You can communicate directly to your counselors via the app and also receive photos throughout the day so you can see what your camper is up to!

BIRTHDAY CELEBRATIONS

Birthdays are a special time and we love to celebrate them with our campers! For campers who have birthdays during the camp session, you are welcome to send in a small nut free treat (mini-cupcakes, mini-muffins, small cookies, cut fruit, etc.) to share with their friends. Talk to your Head Counselor about when you would like to send a treat and we can let you know how many campers are in your child's group.

SICK

If your camper is not feeling well in the morning (has a fever of 100 degrees F or higher, vomiting, diarrhea, yellow mucus, etc.) in fairness to other campers, PLEASE keep them home. It is better to come to camp late because they are feeling better than have to go home because their symptoms do not improve. If your camper needs to be picked up early due to illness, we will keep them as comfortable as possible in the wellness center until you arrive. For the well being of our healthy campers, ill campers do need to be picked up under the following circumstances:

- If your camper develops a fever of 100 degrees F or higher
- If your camper vomits at camp
- General condition of your camper at the discretion of the Health Director is such that they are unable to return to their normal camp activities

We realize that our campers don't want to miss a day of camp, however, we want to minimize the possibility of getting our fellow campers and counselors ill and in turn causing them to miss camp. Campers **MUST** be fever free (below 100 degrees F, without fever reducing medication) for 24 hours before returning to camp. This will help prevent the further spread of illness.

LICE

Anyone can get head lice—mainly through direct head-to-head contact, but also from sharing hats, brushes and other personal items. Head lice are an issue in many communities and do not reflect poor hygiene (lice actually love a clean head of hair!) or socio-economic status. Please do your part to prevent the spread of this communicable condition by checking your child(ren) regularly. We check all campers on Mondays and will contact you immediately if we spot lice. It is much easier to treat if caught early. If you should discover your child has head lice, please notify us **immediately** and **keep your camper home until they have been treated and DO NOT have live lice**. Please contact a trusted medical provider if you need recommendation on how to best treat it. This is the best way to protect your family and community. TICKS

Ticks are part of our natural world and have become more prevalent in Jersey City parks and outdoor areas. We know that children and adults can be exposed to ticks anywhere in nature, whether it is a backyard, a park, or a hiking trail. It is our intention to raise awareness about how to prevent tick related illnesses in general and not to cause you alarm. Bug spray will keep ticks away so please add bug spray to your morning routine. The best way to prevent any illness caused by a tick is to perform a quick and easy body check during evening bath or bedtime. Pay close attention to waistlines, groin, under arms, behind knees, ears and around the hairline. A tick bite in itself does not cause infection. In order to transmit a disease, a tick would need to be attached for at least 24 hours, which is why daily tick checks are so effective. Your child will not be able to start camp without a complete file.

CAMP PAYMENTS AND REFUND POLICY

* Payment can be made with credit card, check or cash.

* Deposits are non-refundable.

* If you cancel on or before 4/15: Your full payment will be refunded minus your deposit.

If you cancel on or before 5/20: 50% of your full payment will be refunded minus your deposit.

If you cancel after 5/20: There is no refund.

* You can find all balance payment options and early care and after care payment options under products on our website.

* If you are not on the payment plan, your camp balance **MUST BE PAID BY 5/21** in order to hold your spot. If you are on the payment plan, payments must be made on the due dates noted on the website in order to hold your spot.

SCHEDULING

- * We do not offer makeups for sicknesses, vacations or inclement weather.
- * Please check your email in the mornings for cancellations or schedule changes due to inclement weather or other reasons.
- * Camp will be closed July 4th.
- * We reserve the right to revoke enrollment at any time for any reason not otherwise prohibited by law.

COMMUNITY

Camp is a place for fun, friends, growth and memories. It is NOT a place for negativity. Any behavior that detracts from the positive experience your fellow campers are having may lead to consequences including dismissal from camp. We have a ZERO tolerance policy for use or possession of tobacco, alcohol, drugs or weapons. This will result in immediate dismissal from camp.
